## Historic Landmark Board – Hybrid Meeting Minutes April 24, 2024

The meeting of the Historic Landmark Board was called to order at 7:03 p.m. by Alana Mace, Board Chair. The meeting was held in a hybrid format via Teams.

## 1. ROLL CALL

Board members present at roll call: Alana Mace, Chair, Kristy Gotham, Linda Graybeal, Keith Teeter (Vice Chair) and new members: David Benson and Ashley Burns. Excused: Kathy Pascoe.

Also present were Councillor Kristine Ireland, Council liaison to the Historic Landmark Board, Staff Liaison Kate Cooke, Cultural Affairs Coordinator.

Before the start of agenda items, introductions were undertaken.

## 2. CONSIDERATION OF THE MINUTES

Alana Macel presented the April 24, 2024 meeting minutes to the Board members and asked for any questions or discussion. Linda Graybeal noted that an amendment to the minutes – specifically that the last paragraph under the September 21, 2024 tour should be deleted as it was not related to that tour. Kate noted that this change will be made to the minutes. There were no further questions or discussion. Alana asked for a motion to adopt the revised minutes. Mary Oswell moved. Keith Teeter offered the second. The motion passed unanimously.

#### **3. NEW BUSINESS**

#### a. Historic Landmark Survey and Project(s) – Update and Action

The Historic Landmark Board had several work sessions since the Board meeting on January 24<sup>th</sup>. Pursuant to this work, Alana created a one-page summary of next steps in the grant application process. She has also created a google doc and is asking for help from Board members to assist in the writing of the grant applications for the Competitive Survey Plan Grant and the Historic Resources/Context Survey Grant. This document is included in this meeting minute packet.

Alana noted that this information can be leveraged to use as educational information for the community, and it also sets up the work program for the Historic Landmark Board for the coming years.

After discussing the grant application elements, Alana asked for a motion to move forward with applications to be completed this summer for the Competitive Survey Plan Grant and the Historical Resources/Context Survey Grant. Mary

Oswell made this motion. Linda provided a second. The motion was passed unanimously.

Alana then asked for a motion that the Historic Landmark Board complete these applications by the end of Summer. Keith Teeter made this motion. Kristy Gotham provided a second. The motion passed unanimously.

The Board members then asked that an additional meeting be scheduled for May 22, 2024 to further discuss the grant applications and take action on the applications. Kate will set up this meeting to adhere to legal noticing requirements.

#### B. California Ranch Selective Intensive Reconnaissance Survey - Noncomp. Survey Plan Grant

#### Goals:

- e. Use the survey to guide an approach to preservation planning and education of the residents of this area and possibly pursue a historic landmark within these houses.
- f. Develop a plan of action to follow up on Recommendations 2, 3 and 4 from the 2015 survey.
- g. Use the survey to build educational and community building infrastructure around survey identified areas to help residents connect, understand, and maintain their properties.

#### Survey Plan Grant To Do:

- 1. Develop guidance for the survey team.
  - a. Review recommendations from previous 2015 survey
  - b. Create an action plan for the Historic Landmark Board for both the Survey and "Outreach, Protection, Recognition, and Interpretation."
- 2. Select the survey companies we would like to request estimates from.
- Request estimates the survey by submitting a scope of work to local survey companies for a bid.

# Westminster Historic Landmark Board (WHLB) 2024 Grant Application Plan

The WHLB plans to apply for two grants in 2024/early 2025 to fund surveys that the Board will use to guide our own work in 2025/2026 as well as use to assist in forming partnerships within the city of Westminster and with City of Westminster's Government with the hope of providing contextual information to the City for its own planning purposes. - 1. Historic Resources/Historic Context Survey Competitive Survey Plan Grant
  - a. Grant Details: The Mini grant through History Colorado
    - i. We will be requesting around \$45,000
    - Cash Match: \$11,250 (25% cash match of the project total required for Nonprofit/Governmental entity owners or if BIPOC Projects\* - no cash match for projects at properties owned by Nonprofit/Governmental entities.)
      - 1. The WHLB is not currently planning for this survey scope to fit under BIOPC.
